Maintains the repository of A.A. related materials primarily relating to the origin and development of A.A. in District 29. Duties include but are not limited to: receives, sorts, indexes and preserves all A.A. related materials pertaining to District 29. Maintains and updates District 29 Group Histories for inclusion in the Archives. Conducts and maintains Oral Interviews of "Old-timers" in District 29.

[Public Information/Cooperation with the Professional Community \(PI/CPC\)](#)

Distributes A.A. literature/information to the general public and professionals who are in contact with alcoholics. Should be thoroughly familiar with the A.A. program and able to provide consistent and accurate information about the Fellowship. Visits might include schools, local businesses, church and civic groups, clergy, health care providers, lawyers and teachers.

Here is what Frances J. has to say!

Getting to know a bit about Frances J. A first ever interview for both Frances and I we met on a Sunday. We went to a park Frances she sometimes goes to pray and meditate. Not wanting to walk far in the humid heat we opted for the first picnic table near the banks of the Colorado River in Bastrop. The insects chirping in the wooded area around us, we started by praying aloud. Both of us giving thanks for that we saw through clear eyes and sober without a hangover. The two of us took turns sharing with God and each other that we were grateful for and asked for peace and strength for those suffering. We then spent a few minutes in silence before getting started. After a few minutes being silly while testing the recorder and a good laugh together we unfolded a bit more about Frances and her sober journey.

Theol J: What attracted you or scared you to AA?

Frances J: I had been here before in and out of the rooms of Alcoholics Anonymous for 36 years, I had always thought I was different. The last time on August 29th, 2017 I thought it was all over! I didn't even know God and I cried out the word God. I feel like He brought me back to what I now feel like was my "first" meeting of Alcoholics Anonymous.

Theol J: What is your favorite group (or groups)? What, if any, is your Home Group?

Frances J: Monday and Wednesday Night Legacies. Monday night Legacies has a special place in my heart because it is the "first" meeting that God brought me back to! The place where it all started. I picked up my Desire Chip and been walking in sobriety ever since. I love that I live in central Bastrop because I can always find a meeting to walk to, well every day except Saturday. I like all of the meetings I can – no I get – to go to and Legacies group is my favorite.

Theol J: Which step did you find the most daunting? What helped you through or inspired you to work this step?

Frances J: I believe my most daunting and challenging step... The one I was really balking on, trying to hold on to my old ideas... was my 9th step!

Theol J: What about the 9th step do you feel was holding you back or what was the fear you encountered?

Frances J: Well once I found out – while working with my sponsor on all the other steps – about step nine, was that it was completely different than what I thought or imaged. It was completely different than what I had ever tried to do on my own, because I never could work the steps alone. That's why I needed a sponsor to guide me through the steps. Particularly Step 9! Well first of all, I found out how many amends I really needed to make and that it is an ongoing life process. However, there were two particular amends that I feared imprisonment, jail and some serious consequences. I am reminded of the story, part of the Big Book, I was willing to do "anything but that" [page 155, "A Vision for You"].

Theol J: What helped or inspired you to get past that fear?

Frances J: Well, I found that any unwillingness – holding on to my old ideas – like "How it Works" says until we were willing to let go, absolutely. So, I had agreed to go to any lengths, my sponsor had to remind me several times! I said, "Man, I knew you were going to say that! Noooooo!" I found that I could pray to God for the willingness to be... willing! That is what I started doing – simply praying to be willing! I found when I made my first amends it was not anything like I had feared. In fact it was more amazing than anything I could have imagined!

Theol J: It seems like some of the experiences I have had, when I am open to any outcome it seems God shows me something more amazing than I could have thought would have happened.

Frances J: Yes, kind of like that, exactly!

Theol J: What is an example of how the program has helped you approach a life situation differently now than before?

Frances J: Oh my God! Yes, Theol there have been quite a few, Frances said with a good chuckle! Actually, when I first got here in my first 30-days, maybe two months, I was actually on what they call the pink cloud! I fell off abruptly and I was shocked! I started realizing one day at a time and that I could live as many one days at a time sober as I desired. The big life changer was when I found my roommate after an attempted suicide. I was left with so much pain and suffering with from finding her and knowing her anguish. Then we found out that she would not be coming back. My sponsor kept telling me to read things in the Big Book. One thing that really helped me was something like – I forget the exact words but – pain is the touchstone of spiritual growth. That started happening for me, I started realizing that God could do anything for me. That we can make it through anything sober.

Theol J: I had a friend recently mention something like when the struggle is greater than the fear of change.

Frances J: Yeah, it's like those painful and hard times... when I come to them and can go through them without a drink. It is so amazing to me! This and everything I have struggled with in my short sobriety. I have not taken a drink in over 10-months. Even, me who had every excuse and looked everywhere for a reason. "You're Mad", "You're not Mad", "I'm happy" it didn't matter, all I wanted was a drink! And that is what I got! I knew, from others that had gone before me that I can hope and I learned how to pray here. No one told me who God was here but I found one with the freedom to choose my own conception. I started praying like never before. I just kept doing my steps, talking to my sponsor, going to meetings, talking to another alcoholic and somehow, I made it through sober. Now I know I can use all of that – what I thought was tragic and struggle – to help another alcoholic who is just about where I was at. In making it through this sober I know that my misery can help someone else.

Theol J: Which of the ninth step promises is your favorite?

Frances J: Actually I love them all! I am amazed at how many of them have come true for me. I think the biggest promise – the one that meant the most to me – “we will suddenly realize that God is doing for us what we could not do for ourselves.” He did that in the last night of my drinking and again at about six or seven months of sobriety as He brought me through my roommates attempted suicide and the changes in my life after. I feel that He has been doing for me what I could not do for myself since. I am truly grateful.

Theol J: Which one or ones did you believe were unobtainable when you started?

Frances J: First of all, I didn't realize those were the 9th step promises. I have learned that there are promises on almost every page of the Big Book. I would read ahead and think they were coming true. As I was working through my 9th step, I had a shift in thinking that helped me to recognize they would continue to come true in bigger ways, with much more ease.

Frances closed with sharing what she thought was the biggest promise of the book. After reading from page xiii in the foreword to the first edition, “We, of Alcoholics Anonymous, are more than one hundred men and women who have recovered from a seemingly hopeless state of mind and body.”, she cleared her throat a bit and reflected. She continued with much excitement in her voice “Man this is telling me more than one hundred people recovered from this disease!” I believed if they could do it, it could work for me. “Now I know that there are millions, all over the whole world!” I was even more confident I could recover. “But I realized, they did not do it alone and neither could I!” She drew emphasis to the fact that first word in the foreword to the first edition was “We”, not I.

We set for a while more listening to the insects, watching birds and together we were sober for another day.



