Upcoming District 29 Election



Basically, every elected officer should attend each monthly District 29 meeting (held on the second Sunday of the month). Additionally, he/she is encouraged to go to South West Texas Area 68 ("SWTA 68") Assemblies and Conferences to see what other Service Committee members are doing in their District and Groups, and, of course, for fellowship and fun.

Any interested person -- anyone who would like to step up and give service at the District level -- is eligible for most of these positions.

Following is a list of the additional responsibilities that each new officer must fulfill.

Officers

• D.C.M. (District Committee Member): Leads monthly district meetings and attends SWTA 68 functions (usually with the District's financial support). Works closely with G.S.R.'s as well as with the Area 68 Delegate, disseminating information between them. In general, the D.C.M. is the ringmaster of district relations with AA as a whole. Usually the D.C.M. is a G.S.R. veteran, has 4-5 years sobriety, and, most importantly, has the time and energy to serve the District well. July 2017



• Alt. D.C.M.: Acts as backup for the D.C.M. who, if for any reason is unable to serve, will step in to assume the D.C.M.'s duties. It is also an apprentice opportunity to prepare this officer to take over as D.C.M. at the next election.

• Secretary: Takes and transcribes minutes of all District meetings and provides a copy of past minutes to members attending District meetings. Maintains a current list of the names and contact information of all District Committee members. Informs members of all upcoming events and meetings.

• Treasurer: Maintains financial records including all monetary contributions; provides written financial report at each District meeting and keeps separate ledger on earmarked contributions. Make District aware of upcoming expenses and needs by coordinating with DCM and Committee Chairpersons.

<u>Committee Chairpersons</u>

• Archives: Maintains the repository of AA-related materials primarily relating to the origin and development of AA in District 29. Also, maintains and updates District 29 Group Histories as well as Oral Interviews of "old-timers" in District 29.

• Correctional Facilities: Coordinates Bastrop County Jail meetings and its officials and maintains updated list of volunteers. Coordinates with Federal Prison Officials to take meetings into the federal facility. Provides AA literature to correctional facilities.

• Public Information/Cooperation with the Professional Commumunity (PI/CPC):

Distributes AA literature/information to the general public and professionals who are in contact with alcoholics. Should be able to provide consistent and accurate information about the Fellowship. Encouraged to make visits to schools, local businesses, church and civic groups, clergy, health care providers, lawyers and teachers. July 2017



Treatment Facilities:

Coordinates the work of individual AA members and groups interested in carrying the message of recovery to alcoholics in treatment facilities in District 29. Coordinates with Area 68 Treatment Chair a means of "bridging the gap" from a treatment facility to an AA Group in District 29.

• Grapevine: Responsible for disseminating information about the Grapevine and LaVina and other Grapevine materials that are available. Encourages groups to subscribe to the Grapevine to further carry the message.

• Literature: Facilitates purchase of GSO literature for all District 29 Committees, if requested. May provide literature displays as well as a place to purchase available literature.

• News;etter: Prepares & edits monthly District 29 Newsletter as outlined in the current District 29 Procedures and Guidelines. Chair should have computer software capable for the compilation of the Newsletter. Coordinates with Committees on input and deadlines.

• Hill Country Intergroup Representative: Represents District 29 by attendance at monthly HCI meetings. Provides information to the District about local AA community events and volunteer opportunities. Minimum of 1 year of sobriety is suggested.
