#### From Living Sober Chapter 19 – Being Grateful

The following illustrations may not be an exact fit for you, but even if the words are new, perhaps your emotions will be moved to recognize familiar emotional tunes accompanying them. Some are intentionally exaggerated, to make the point unmistakably clear. Others may, at first glance, look trivial. Scores of us have found, though, that easy little changes are a good starting point for a big strong recovery.

When our favorite toddler falls, bumps her head, and squalls, it's fairly simple to see whether she is seriously hurt or just frightened. Then we have a choice: We can either shriek hysterically because the child got hurt or frightened, and carry on over what could have happened; or we can keep our cool and be comforting, grateful that no serious harm occurred.

When our 90-year-old grandfather, long ill and unhappy, finally dies, we again have a choice. We can insist that the only thing to do is rage in grief and anger at the surprise of it, or wallow in guilt—and perhaps drink in either case. Or we can, besides being sad, remember that he did have a long, often good and happy life; that we did try to be good to him and assure him of our continuing love; and that his suffering and unhappiness are now over. It is doubtful that he would appreciate our using his passing as an excuse to get drunk and endanger our health.

When we finally get to visit a place long dreamed of, we can concentrate on the inconveniences of our lodging and the weather, the passing of the good old days, and the fact that we have only a few days or weeks to spare. Or we can be grateful that we finally got there at all, and keep adding to a mental list of the delights we can find if we look for them.

We can watch out for a tendency to say, "Yes, but—" in response to any optimistic, complimentary, or positive statement. A friend's good luck or his youthful appearance, or a celebrity's plug for a charity may tempt us to say sourly, "Yes, but—" But... does this thinking habit help anyone—including ourselves? Can't we let something good simply be? Can't we just be pleased about it, rather than trying to downgrade it?

Those who try to quit smoking realize two possibilities are open: (1) continual moaning about how hard it is, This time it won't work, either," and "See, damn it, I just lit another one"; or (2) enjoying a deep smoke-free breath when we think of it, being glad an hour has passed without a drag, and, even when a cigarette is unconsciously started, congratulating ourselves for putting it out without smoking it down to a stub.

If one of us wins only \$500 in a sweepstakes that has a \$50,000 top prize, the sensible mood is easy to pick out. It is *not* bitterness at losing the biggest pot.

We continually find opportunities to make similar considered choices, and our experience convinces us that feeling gratitude is far more wholesome, makes staying sober much easier. It will come as a pleasant surprise to discover that it is not difficult to develop the habit of gratitude if we just make some effort.

If you have any questions or suggestions, please feel to contact me. I do love being of service. As always thank you for allowing me to be of service to this wonderful fellowship in District 29.



### **The AA Traditions and Concepts Series 2019**

The month of July brings us to Tradition 7 and Concept VII! We need only four more volunteers to finish the series as we already have someone lined up for September! Theol J. is back at the keyboard this month, willing to accept things I cannot change and finding balance hopefully not based in fear.

#### **Tradition 7:**

**Short form:** Every A.A. group ought to be fully self-supporting, declining outside contributions.

**Long form:** The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

My experience around how most uphold this tradition has allowed me to practice acceptance. I accept that many have a more restrictive interpretation of this tradition than I do and yet I can participate in any of the fundraising efforts governed by these different views and have just as much fun, do just as much service and stay just as sober as I could if I had the exact same interpretation as those around me. I can accept that disallowing contributions from any non-A.A. source is what works to keep peaceful balance in the groups involved. I can see the merit in the different than my opinion and be open to talk about our differences in how we interpret this tradition and because I can accept that neither of us are going to necessarily change our minds I can peacefully support our fundraising. Who would have thought... I can entirely support and get behind something that I don't fully agree with definitely not the fellow I was when I was drinking, I would have set all my energy to proving my side of the interpretation was correct.

Also I can state, in writing, no less that I support this view which is different than mine but I think does a reasonably good job of summarizing the prevailing interpretation of Tradition 7 which I have encountered...

We shall not accept any amount of money no matter how small from any organization nor shall we accept donations from non-members. If we become aware of attempts from non-A.A. members to contribute we are charged with the responsibility to polite decline on behalf of A.A.'s tradition of self-support.

#### **Concept VI:**

**Short form:** The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.

**Long form:** The Conference recognizes that the Charter and the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness.

Finding balance in all things, to me is what this program is about! Concept VII shines a light, I think, on the balance of running of A.A. Pointing out the General Service Board has the legal right to run the organization without regard for what the Conference suggests to implement. Two-thirds of the Conference are delegates from the individual groups. The group's contributions are what fund (the "purse") the General Service Board. The groups could withdraw financial support, if the General Service board went too far afield of the wishes of the Conference. To-date there have been no Conference recommendations vetoed by the General Service Board. There is a certain trust and respect between the two organizations that has developed a working relationship that keeps A.A. going. This balance with a not often (or ever) needed to be used ability of each party to keep the other in check, is something I seek in my individual relationships with others. I hope that through mutual trust these relationships are able to stay in harmony and balance, not because of fear inspired by the implied threat of dissolution or withholding something but rather balance brought about through mutual respect and openness which allows both parties to openly express their opinions and feelings. As I learn daily, at times I must overcome my past to feel secure enough to stay in this balanced place. I hope that like A.A. there is a graceful balance of power in all of your relationships.


